# LYCOMING LAW ASSOCIATION President's Report 2024

The accomplishments of the LLA this past year are in large part due to the work of the entire leadership team. Thank you to each member of the executive committee for the work you put in this year. I also want to acknowledge all for the hard work and dedication of Michele Frey, our executive director. She, without doubt, makes serving as the President of this organization a seamless and stress-free job. Now that my presidency has ended, I look forward to continuing as a member of the LLA for the remainder of my career.

I would like to point out several of the highlights from 2024:

### January 2024

The annual banquet was held at the Carriage House and catered by Chef Housh and Ann Catering. There was record attendance at the event by members as well as all sitting members of the Common Pleas judiciary along with retired Judges, members of the Federal Bench and Magistrate Judges. The LLA faced a copyright infringement claim arising out of a CLE presentation that was published on the LLA website. The issue was resolved and as a result the LLA no longer publishes presentations on the website and created a DMCA Designated Agent Registration Account to help address any future allegations against the LLA.

Throughout the year, the LLA continued to offer high-quality CLES, with 22 live programs being offered. Particularly popular was the CLE regarding AI.

The executive committee has proposed changes to the bylaws regarding non licensed law clerk membership in the association as well as the duties of the Treasurer. The proposed changes have been submitted to the membership and will be voted on at the 2025 Annual meeting.

The Louise Larzelere Chatham Award was created commemorating the 100-year anniversary of the first female attorney in Lycoming County. The award will be presented to a female member of the LLA in 2025.
