**Essay Contest:**Grades K-5 – Not to exceed 300 words

Grades 6-12 – Not to exceed 1,000 words

- "E Pluribus Unum" literally translates to, "out of many, one." How does our representative government, as established by the Constitution, ensure that the voices of a diverse citizenry are heard and respected?
