Criminal: Suppression motion; probable cause for vehicle stop where officer had information that the driver’s license was suspended; reasonable suspicion for canine search of vehicle where the only evidence was that defendant had recently visited a residence where others were arrested for drug offenses. (Garg031725C) (Posted: March 18, 2025)
- ▶ **Commonwealth vs. Pedraza** (03/10/2025)—Judge Ryan M. Tira
Criminal: Suppression motion; search of vehicle; expectation of privacy in another’s vehicle; automatic standing to challenge a search where a possessory offense is charged; plain view doctrine; valid consent to search; motion to dismiss; prima facie case of possession of firearm by fugitive. (Pedraza031025t) (Posted: March 16, 2025)
- ▶ **Commonwealth vs. Stroup** (03/10/2025)—Judge Nancy L. Butts
Criminal: Post conviction relief act petition; timeliness; merits of claim that counsel should have filed a post-sentence motion to request concurrent sentences when the plea agreement was for consecutive sentences. (Stroup031025bt) (Posted: March 16, 2025)
- ▶ **Commonwealth vs. Robinson** (03/10/2025)—Judge Nancy L. Butts
Criminal: Motion to reconsider sentence; weight given to defendant’s history and characteristics, age, rehabilitative needs and mental and physical health issues, lapse of time of the majority of his criminal history, and his mental health diagnoses; sentencing court presumed aware of contents of presentence investigation report. (Robinson031025bt) (Posted: March 16, 2025)
