Criminal: Post-sentence motion in arrest of judgment; sufficiency of evidence of possession of drugs with intent to deliver; consideration of volume of heroin, manner in which it was packaged and amount of protective gear in house; connection of defendant to home by observation of his coming and going and his identifying documentation in the house; motion for new trial due to court’s refusal to drug test witnesses; refusal of court to exclude late discovered video evidence; prejudice; manifestly excessive sentence; “volume discount” for multiple crimes; consideration of previous record and sales of dangerous substances such as fentanyl and methamphetamine. Civil: Objections to discovery; relevancy of inquiries; premature questions on issues of financial means to pay judgment; duty to respond to requests by separately responding to each request and identifying documents responsive to that request. (Harris011822t) (Posted: January 26, 2022)

Criminal: Suppression motion; adequacy of search warrant to establish probable cause of a crime; knowing, intelligent, and voluntary waiver of *Miranda* rights; totality of circumstances; probable cause for search of cell phone data without evidence that crimes of abuse of corpse, tampering with evidence or obstruction would be contained in phone. Criminal: Habeas corpus petition; sufficiency of evidence of possession of drugs; constructive possession; mere association, suspicion, or conjecture; evidence of defendant’s residence at home where currency, drugs, bags and sealers, and guns were located; circumstantial evidence of conspiracy; totality of circumstances inferring agreement between defendants; sufficiency of evidence that gun was stolen to establish receiving charge; arrest warrant alone was sufficient justification for police to enter the home to locate and arrest defendant; probable cause or exigency; stale warrant; evidence from search warrant was “fruit of the poisonous tree.” (Tennison012122bt) (Posted: January 26, 2022)
